Mayor Fanucci and Chief Financial Officer Susan Baldosaro supplied City Council with the 2025 budget presentation. Councilmember Spinelli asked on the status of Jake's Park to which Solicitor Tonetta replied there were glitches with the State in allowing the City tie into their sewer system however that has been resolved and the City is ready to break ground in the Spring and move forward.

Councilmember Dr. Arthur asked if resident taxes are going to increase. The Mayor responded that if at all, it may only be a couple cents. He stated the reason of uncertainty at the moment is because some items are still influx with skyrocketing costs including healthcare, benefits, etc... All councilmembers thanked the Mayor, Administration and particularly the Finance Department for all their hard work in preparing the budget.

The City Clerk read: Public comment provides an opportunity for members of the public to inform the governing body about their views. The governing body prescribes to City Council's by-laws and the NJ Statutes on Open Public Meetings when engaging during public comment. As such, each individual shall have a 5-minute limit to comment; cannot yield time to another individual; may only approach the podium once during public comment for any one topic; vulgar/offensive language is prohibited; and City Council will not engage in dialogue with the public during this time. The governing body maintains model courtesy and respect and requires members of the public to do the same.
